Dear Interested Candidate,

Thank you for your interest in the Practical Nursing program. The program is a twelve (12) month, day program. Two (2) cohorts will be admitted each year (one in January and one in July). Attached is the Required Course Sequence which details the terms and courses. Admission to the Practical Nursing Program is highly competitive. We anticipate that the number of interested candidates will exceed the number of seats available.

Please note the selection process for the July 2026 cohort will be changing

Process for January 26 cohort:

The pre-screening process establishes eligibility for admission into the Practical Nursing Program. You must:

- have an official high school transcript or GED diploma with scores.
- if you are a high school graduate from a foreign country or have an out-of-state GED,
 obtain a Certificate of Preliminary (CPE) Education from the Pennsylvania
 Department of Education.
- be at least 18 years old
- be a U. S. citizen, permanent resident, or eligible non-citizen.

Applicants who meet the following requirements are considered for admission (meeting the requirements is not a guarantee of admission into the program):

- 1. Meet the pre-screening requirements listed above and the essential qualifications.
- 2. Complete an application.
- 3. To qualify for admission into the Practical Nursing program, students must complete BIO 120 Human Body Systems for Health Sciences (6) credits (or the equivalent of Anatomy & Physiology I and Anatomy & Physiology II) and achieve a grade of C or higher, which can be completed at P.I.T. or transferred from a Middle States Accredited institution.
- 4. Complete AHT 105 Healthcare Foundations course (or the equivalent med-term and math courses) with a grade of C or higher.
- 5. Submit official high school and/or post-secondary education transcripts.
- 6. Satisfactory background checks: including a criminal record check, a child abuse clearance for Pennsylvania, and an FBI Fingerprint background check.
- 7. Completion of satisfactory drug screening.

- 8. Satisfactory physical examination including immunizations, titers, TdaP, and tuberculosis screenings. If tuberculosis screening is positive, Chest X-ray with a doctor's note within last 5 years is required.
- 9. American Heart Association BLS Provider (CPR & AED Adult, Infant, child) certification
- 10. Flu vaccine
- 11. COVID-19 vaccine and recommended boosters per CDC guidelines.

Enclosed are the MINIMUM ADMISSION REQUIREMENTS DECLARATION and FREQUENTLY ASKED QUESTIONS which provide further information about the Practical Nursing program. If you do not meet the requirements, Pennsylvania Institute of Technology has other programs for people interested in a health care career. PRACTICAL NURSING PROGRAM MINIMUM ADMISSION REQUIREMENTS DECLARATION

Eligibility Requirement:

- Official high school transcript or GED with scores.*
- * Please note: GED from a state or jurisdiction other than PA and Foreign high school records requires a Certificate of Preliminary Education (CPE) from PA DOE.
- At least 18 years of age provide documentation
- U. S. citizen, permanent resident, or eligible non-citizen (for financial aid eligibility)

Pre-requisite Requirements

- Must complete BIO 120 Human Body Systems for Health Sciences (or the equivalent of Anatomy & Physiology I and Anatomy & Physiology II) with a 'C' grade or higher from a Middle States Accredited institution
- AHT105 Healthcare Foundations course (or the equivalent of College Math and Medical Terminology) with a 'C' grade or higher from a Middle States Accredited institution.

Admission requirements:

- Pennsylvania Institute of Technology College Enrollment Application
- Official high school transcript, GED transcript, or PA DOE CPE
- Official college transcripts, if applicable
- Completion of a PA Criminal background check within 12 months (Completed through ADB)
- Completion of a PA Child Abuse background check within 12 months (Completed through ADB)
- FBI Background Check is required within 12 months (Completed through ADB)
 - Depending on results additional background checks maybe required
- Completion of satisfactory drug screening within 12 months; IF positive drug screening result, test may be repeated onetime AFTER 60 days. (Completed through ADP)
- Physical exam by health care provider within 12 months
 - Please note form MUST be signed and dated by provider
- Proof of immunization vaccination record OR Mumps, rubella, rubeola, and varicella titers showing immunity. (uploaded and approved through ADB)
- Booster vaccination(s) of mumps, rubella, rubeola, and/or varicella if titer non-reactive/nonimmune with a repeat titer to verify immunity. (uploaded and approved through ADB)
- Tetanus-diphtheria (TdaP) booster vaccination within the last 10 years (uploaded and approved through ADP)
- Tuberculosis screening one step OR QuantiFERON blood test: negative results within 12 months
 Please note: if positive results must provide Chest X-ray result done within last 5 years showing no active TB with an annual doctors note. (uploaded and approved through ADB)
- Hepatitis B vaccination series of three (3) doses completed OR in progress (uploaded and approved through ADB)
- Seasonal Flu vaccine is required
- COVID-19 vaccine is required per CDC guidelines to be considered "fully vaccinated"
- Current American Heart Association (AHA) BLS Provider certification (Adult, child, infant, &AED)
- Health insurance
- No outstanding fees owed to college
- Reliable transportation to clinical sites
- Meet essential qualifications

NOTICE OF SELECTION PROCESS CHANGES:

The Walter R. Garrison College of Nursing is committed to ensuring a fair, transparent, and equitable selection process for our competitive Practical Nursing program. Beginning with the **July 2026 cohort**, the selection process will be updated to include:

- A formal application window
- A rubric-based evaluation of applicants

The application window for the July 2026 cohort will open on **March 1, 2026**. A detailed rubric outlining the evaluation criteria will be published in advance of this date to allow applicants ample time to prepare. These changes are designed to further align our selection process with best practices in nursing education, and to provide all applicants with clear expectations and evaluation standards. Continue to monitor official College communications for the release of the rubric and further application instructions.

NOTICE OF IMMUNIZATION REQUIREMENTS:

While PIT and the Practical Nursing Program recognize certain exemption status, current clinical partners **do not accept medical or religious exemptions** currently. All background and health clearances must be obtained to attend clinical and satisfy the clinical requirement of the program.

NOTICE OF RELIABLE TRANSPORTATION:

Students in the program are required to have reliable transportation for all program activities which includes clinical site attendance. Clinical sites are selected based on their ability to contribute to the learning requirements of students in the program and as such may not always be easily assessable via public transportation.

NOTICE OF CLINICAL SITE REFUSAL:

Clinical placements are secured through affiliate healthcare partners, and acceptance at these sites is a condition of successful program progression. Any refusal by an affiliate clinical site to accept or continue a student's placement—whether due to conduct, background checks, health requirements, professional behavior, or other circumstances occurring outside of, prior to, or during program participation—may result in program dismissal or inability to progress in the program.

NOTICE OF LIVE-PATIENT CLINICALS:

Please be aware that clinical training requires students to perform patient assessments and deliver care to individuals across a wide range of health conditions and states. By nature, this training carries an **inherent risk of exposure to illnesses, infections, and other health-related hazards**. The College of Nursing and its clinical affiliates maintain policies and procedures to minimize these risks, and students are expected to strictly adhere to all safety protocols, infection control practices, and professional standards. Compliance with these measures is essential to protecting both yourself and the patients under your care.

Clinical Health Programs Medical Marijuana Procedure and Acknowledgement

The Pennsylvania Department of Health has implemented the Pennsylvania Medical Marijuana Program, a component of the Medical Marijuana Act (MMA) that was signed as law on April 17, 2016. This program provides access to medical marijuana for patients with serious medical conditions as defined by the Pennsylvania Department of Health.

Currently, the federal government regulates drugs through the Controlled Substances Act, which does not recognize the difference between medical and recreational use of marijuana. Under federal law, marijuana is a Schedule 1 controlled substance, which means that it is considered to have no medical value. Practitioners may not prescribe marijuana for medical use under federal law.

Students entering any Clinical Health Programs are required to have laboratory screenings for drugs and alcohol upon admission to the clinical phase of the program and on a yearly basis while participating in the clinical experiences. As per current policy, if the results are positive, the student will be dismissed from the program.

Students using medical marijuana will not be eligible for clinical placement in any P.I.T. clinical program, due to the current discrepancy between state and federal law regarding Drug Free Work Place Act and the MMA. Businesses who are not in compliance with federal law are at risk for criminal or civil charges; and additionally may find issue with eligibility for federal contracts and grants.

Additionally, Pennsylvania's Medical Marijuana statute specifically provides that an employer does not have to accommodate an individual in a safety sensitive position if that person is under the influence of medical marijuana. Most positions involving direct patient care will be considered safety sensitive positions.

Students should also understand that under current Pennsylvania State Board law, many health career licensing boards require drug screening at the time of application for licensure. Similarly, most health care employers will perform routine drug screening as a condition for employment, as these positions involve direct patient care, and are considered safety sensitive positions. This discrepancy between federal and state law allows our clinical partners to deny student placement for clinical experiences and the State of Pennsylvania to deny licensure.

In order to be transparent with this entire process, we recognize our responsibility to fully inform students of P.I.T.'s procedure regarding the use of medical marijuana. Due to current laws we cannot provide admission to the clinical phase in any of our Clinical Health Programs and students who have been admitted and are later to be found positive for medical marijuana will be removed.

FREQUENTLY ASKED QUESTIONS

1. What is the Practical Nursing (PN) Program?

The PN Program is a Certificate Program and is designed to prepare the student for a successful nursing career and employment in the healthcare field, to facilitate personal growth experience, and to provide Registered Nurse program transfer opportunities.

2. What are the requirements for admission into the PN Program and who is responsible for paying for the cost, if any?

See attached MINIMUM ADMISSION REQUIREMENTS DECLARATION document.

3. Is the PN Program approved?

Yes. The program is approved by the Pennsylvania State Board of Nursing and Effective June 6, 2024, this nursing program is a candidate for initial accreditation by the Accreditation Commission for Education in Nursing. This candidacy status expires on June 6, 2026.

4. Will criminal history prevent acceptance into the program?

It depends on the specific details of the criminal history. One misdemeanor may not preclude acceptance into the program while more than one and/or a felony conviction usually does. To participate in clinical experiences a "no record" status must be reported on child abuse background checks, therefore, a history of child abuse precludes acceptance into the program. If there is an "arrest" or "charge" listed on your criminal background check that does not have the "disposition" you will be required to provide official documents such as criminal background check from that state.

The Pennsylvania State Board of Nursing requires that the program inform applicants that the State Board of Nursing:

• may deny a license or the privilege of sitting for licensing examination to an applicant who has been convicted* of a felonious act prohibited by the act of April 14, 1972 (P.L.233, No.64) known as "The Controlled Substance, Drug, Device and Cosmetic Act," or convicted of a felony related to controlled substance in a court of law of the United States or any other state, territory or country unless:

- may refuse a license in any case where the board finds the applicant:
 - 1) Is guilty of gross immorality.
 - 2) Is unfit or incompetent by reason of negligence, habits, or other causes.
 - 3) Has been convicted of a felony or a crime of moral turpitude, or been dishonorably discharged or discharged under circumstances amounting to dishonorable discharge from the military.
 - 4) Is addicted to alcohol or is addicted to hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination, or if he or she is judged to be mentally incompetent.

You will be asked these following questions upon acceptance and on the state licensure application:

*The term "convicted" includes a judgment, found guilty by a judge or jury, pleaded guilty or nolo contendere, received probation without verdict, disposition in lieu of trial or Accelerated Rehabilitative Disposition. If the answer is yes to either one of the above questions you may have difficulty obtaining a license in Pennsylvania.

DECEIT IN THE ADMISSION PROCESS IS CAUSE FOR DISMISSAL FROM THE PROGRAM

5. Are there any Pre-requisites?

Yes, to qualify for admission into the Practical Nursing program, students must complete and achieve a grade of C or higher for BIO 120 Human Body Systems (or the equivalent of Anatomy & Physiology I and Anatomy & Physiology II), which can be completed at. P.I.T. or transferred from a Middle States Accredited Institution. Students must also complete AHT105 Healthcare Foundations course (or equivalent College Math and Medical Terminology) with a C or higher which is completed at P.I.T.

6. How many credit hours is the program and how long will it take to complete the program? Are the credits transferable to another school or college?

The curriculum is comprised of 50 nursing credits. The curriculum is divided into 4 terms of instruction for a total of 1500 hours. The full-time day program is a twelve (12)

month program; the possibility of evening/weekend clinical rotations exists. Credits earned are not necessarily transferable to another school or college.

There are many opportunities for Licensed Practical Nurses to move up the educational ladder to obtain further specialty certifications or become a Registered Nurse. Both associate degree and bachelor's degree programs are available. Many even offer credit for your practical nursing education.

7. What are the roles and responsibilities of a licensed practical nurse?

Nursing is an art and science dedicated to meeting the healthcare needs of individuals of all ages and communities. Licensed practical nurses (LPNs) provide healthcare in a variety of settings such as long-term care facilities, hospitals, physician's offices, homes, rehabilitation facilities, and clinics. LPNs work under the supervision of a licensed professional (registered) nurse, a licensed physician, or a licensed dentist. The nursing actions performed by LPNs are extensive. The list includes, but is not limited to, provide fundamental care, collect client information and data, perform routine monitoring, administer medications, enteral feedings, and intravenous therapy, and perform wound care, dressing changes, and respiratory treatments.

LPNs provide health teaching, monitor effectiveness of treatments, and document data, actions, and responses. LPNs are integral members of the healthcare team working together to assist the individual or family in the prevention of illness, restoration of health or adaptation to illness, and achievement of comfort.

8. Is there tutoring available?

P.I.T. is organized for student success. There are opportunities for peer, group, and private tutoring in our Student Resource Center, Student Innovation Center, Nursing instructors will be available for academic advising, tutoring, guidance, and support of nursing students.

9. What types of student services are available on campus?

Student Affairs provides academic support and career and transfer counseling as well as referral to social and community services. Other student services available include: student cafe, student lounge, and student lockers.

10. Will I receive a license immediately upon completion of the PN program?

No. Graduation from the PN program qualifies you to apply for a license and apply to take the NCLEX-PN® (National Council of Licensure Examination-Practical Nursing). You must apply to the State Board of Nursing and register for the examination. The State

Board of Nursing determines if you are eligible to take the examination. When you pass NCLEX-PN® you will be issued a license.

11. What sites are used for clinical learning experience? Is transportation provided to and from the clinical sites?

Clinical environments are hospitals, nursing homes, assisted living, acute care facilities, community centers, pediatric facilities, correctional facilities, and elementary schools. Clinical also occurs on campus in the Simulation lab and may also occur online with a Virtual client and assignments. Negotiations for additional clinical environments for clinical learning experiences are ongoing. The possibility of evening/weekend clinical rotations exists. Clinical sites are not limited to Delaware County, and maybe out of state. Students are responsible for their own transportation. Clinical site placement is decided by nursing faculty. Requests for clinical site placement with peers or at specific agency will not be honored.

12. What type of patient/patients do student nurses care for during clinical learning experiences?

The Pennsylvania State Board of Nursing requires that clinical learning experiences provide opportunities for students to care for men, women, and children in a variety of age groups. Therefore, each student will be assigned to (and expected to) care for men, women, and children with a variety of health problems. Students are not permitted to refuse a patient care assignment.

13. What resources are available to help fund my nursing education?

Financial aid is available for those students who qualify, through federal, state, institutional, and special programs. Student loans are available. Some employers offer tuition forgiveness (repay outstanding loans for education) programs in exchange for employment. There are also professional and community organizations that offer scholarships to nursing students. For further information on federal, state or college aid go to www.fasfa.gov. P. I. T. Student Financial Aid Office is available to assist students in applying for financial aid.

14. Are there computer requirements for the nursing program?

Yes. All exams that are given online are recorded and monitored live via a Webcam. In addition, virtual patients can only be accessed through a laptop or desktop. iPads and smart phones can be used for lecture but are not compatible with other products, learning platforms, and software.

15. Is my acceptance into the program guaranteed?

Acceptance into the Practical nursing program is a highly competitive process with limited seating available. All perspective students must ensure that they have all minimum admission requirements met by the deadline prior to beginning the program.

16. Can I really lose my spot in the program before being accepted?

Since the practical nursing program is so competitive, we rely on indicators that demonstrate a student the exhibits the types of behaviors necessary to be a safe and competent nurse. This means we are in constant communication with P.I.T. faculty and staff across different areas of the college and receive reports of positive and negative interactions. Students who exhibit behaviors against our standards of professional conduct and treat members of the college community with aggressive, abusive, or disruptive behavior can be removed from consideration from the nursing program before acceptances has been extended. This includes interactions with admissions, academic support, faculty outside of the nursing program and staff members of the college. Additionally, students found to be breaking campus policies and rules, such as ignoring parking lot signage, or using profane language can be removed consideration at the discretion of the program director.

ESSENTIAL QUALIFICATIONS

All individuals, including persons with disabilities, who apply for admission to the Nursing program must be able to perform specific essential functions with or without reasonable accommodation. The following outlines the abilities and behavioral characteristics necessary for the student to be admitted to, continue in, and graduate from, the Nursing program at P.I.T.

These essential qualifications are standards of admission.

The applicant should carefully review the essential qualifications for the program and ask questions if not familiar with the activities or functions listed. The applicant must decide if he or she has any limitations that may restrict or interfere with the satisfactory performance of any of the requirements. It is the applicant's responsibility to meet these essential qualifications if accepted into the program.

The applicant should consult with the program director to discuss any individual situation if they may not be able to meet these essential qualifications. Requests for reasonable accommodation will be considered. Contact the program director if you have any questions about this matter.

Communication

- 1. Communicate verbally using clear and effective English.
- 2. Write legibly in clear and effective English using correct grammar, punctuation, and spelling.
- 3. Quickly and accurately comprehend and follow verbal instructions in English.
- 4. Quickly and accurately read, comprehend, and follow written instructions in English.
- 5. Actively participate in group discussions
- 6. Use communication equipment telephone, computer, other device used for communication.

Physical Skills

- 1. Possess fine and gross skills sufficient to handle equipment and provide safe and effective patient care.
- Exert maximum physical force to lift, push, pull or carry objects up to 35 pounds (oxygen cylinders, beds, patients, or any other type of equipment) as indicated by Occupational Safety and Health Administration (OSHA) and National Institute for Occupational Safety and Health (NIOSH) Guidelines (9/2021)
- 3. Move quickly, freely, and safely around the assigned work area and patient care settings.
- 4. Sustain professional activities for up to 8 or more hours.
- 5. Reach above shoulder level (to manipulate equipment)
- 6. Reach below waist level (to manipulate equipment)

- 7. Move upper and lower extremities, back, hips, and knees without restriction bend, stoop, and squat.
- 8. Keep hand and arm steady while moving arm or while holding arm and hand in one position.
- 9. Make precisely coordinated movements of the fingers of one or both hands to grasp, manipulate, or assemble very small objects.
- 10. Coordinate two or more limbs (for example, two arms, two legs, or one leg and one arm) while sitting, standing, or lying down.

Observation and Sensory Skills

- 1. Hear, comprehend, and interpret conversation and sounds not solely based on visual cues (including alarms, monitors, faint sounds, such as heart and breath sounds, taking blood pressure)
- 2. Ability to see details at close range (within a few feet of the observer) and at a distance.
- 3. Function efficiently in various degrees of light, from dark to bright lighting
- 4. Differentiate colors, varying shades of same color, and shades of black, white, and gray.
- 5. Read fine print and handwriting.
- 6. Detect and distinguish odors from clients and environment.
- 7. Distinguish textures, degrees of firmness, temperature differences, pulse rate and vibrations; feel anatomical landmarks and veins.
- 8. Distinguish and describe the patient's affect, body language, and physical responses that the patient cannot verbally relay (i.e., facial expressions, sweating, trembling, color change, bleeding, etc.)

Intellectual, Cognitive, and Critical Thinking Skills

- 1. Concentrate on a task over a period of time without being distracted.
- 2. Apply principles of critical, logical thinking to define problems, collect data, establish facts, and draw sensible and valid conclusion.
- 3. Combine pieces of information to form general rules or conclusions (includes finding a relationship among unrelated events).
- 4. Perform multiple tasks simultaneously.
- 5. Arrange things or actions in a certain order or pattern according to a specific rule or set of rules (alphabetize)
- 6. Integrate information quickly, consistently, accurately, especially in an emergent situation.

Behavioral / Social Skills / Ethics

 Display a prominent level of professionalism and discretion in all actions and communication (written, oral and electronic) with all members of staff, faculty, and the public.

- 2. Function effectively and display integrity, poise, and emotional stability under stress (emergency, critical, or dangerous situations) in actions with all (peers, patients, staff, and faculty)
- 3. Use team approach to carry out responsibilities.
- 4. Respond to all persons sensitively and with respect for cultural diversity.
- 5. Maintain general good health and self-care.
- 6. Display flexibility and adapt to changing environments.
- 7. Manage time effectively.
- 8. Accept responsibility for own behavior and be forthright about errors or uncertainty.
- 9. Refuse to perform or participate in any illegal, unethical, or incompetent acts, to include but not limited to the following: falsifying or knowingly making incorrect entries into a patient's record or related document; copying other student's written assignments; cheating on a quiz or examination; making untrue statements to a faculty member or administrator.
- 10. Monitor/assess performance of self, other individuals, or organizations to make improvements or take corrective action.
- 11. Capable of developing mature sensitive and effective relationships (with patients, staff, coworkers, etc.)
- 12. Follows all faculty, staff, and college rules regulations and instructions at all times.

By signing below, I acknowledge and agree to the following conditions of admission and participation in the Practical Nursing Program:

1. Documentation and Records

- All submitted application materials and required forms become the permanent property of the College and will not be returned.
- o I authorize the College to share my healthcare documentation with affiliate clinical sites as necessary for clinical placement.

2. Application Integrity

 I understand that any falsification, misrepresentation, or deceit in the admissions process is grounds for denial of admission or immediate program dismissal.

3. Admission Documentation Requirements

- I must submit one of the following: an official high school transcript, GED transcript, or PA Department of Education (DOE) Certificate of Preliminary Education (CPE).
- I understand that admission will be denied if I have a disqualifying criminal background check, child abuse clearance, or drug screen result.
- I must provide a completed health examination form, including immunization history and/or serological verification. Admission will be denied if results are disqualifying.
- I must provide proof of COVID-19 vaccination and seasonal influenza vaccination in accordance with clinical site requirements. Failure to do so will prevent clinical attendance and result in course failure.
- I must provide documentation of current American Heart Association (AHA)
 Basic Life Support (BLS) Provider certification (including CPR and AED for adult, child, and infant).

4. Clinical Placement & Health Considerations

- Participation in clinical training is contingent upon acceptance by affiliate clinical sites. If a clinical site refuses placement due to health, background, behavior, or other reasons, I may not be able to continue in the program, resulting in course failure or dismissal.
- I understand that illness, injury, or health limitations may restrict my ability to participate in clinical education and could result in course failure or dismissal.
- I accept the inherent physical, mental, and emotional demands of nursing education and will evaluate my ability to meet these demands prior to program entry.

5. Professional Standards

- I may forfeit admission or be dismissed if I engage in behavior inconsistent with the standards of professional conduct established by the College.
- I understand reliable transportation is required for clinical participation.
 Lack of transportation is not an excuse and may result in dismissal.
- I have reviewed and understand the College's Clinical Health Program Medical Marijuana Procedure.

6. Program Structure & Admission Process

- I understand that the Practical Nursing Program is an accelerated, full-time,
 1,500 clock hour, 12-month day program.
- o I understand that admission to the program is competitive and spacelimited; meeting minimum requirements does not guarantee admission.
